## Martin County Economic Development Authority (MCEDA) July 11, 2016 Martin County Courthouse, Fairmont, MN

The meeting was called to order by Chris Pierce at 12:00 p.m. Board members present were: Elliot Belgard, Randy Grupe, Brent Schultze, Larry Baarts, Jerry Clark and Dan Schmidtke. Absent: Jerry Clark and Chris Pierce. Others present: Linsey Pruess, Coordinator Fairmont Economic Development Authority (FEDA), Dan Whitman, Martin County Assessor, Scott Higgins, County Coordinator.

Motion by Belgard, seconded by Schultze to approve the agenda as presented. Carried unanimously.

No minutes of June 6, 2016 Board meeting.

No monthly client report or updates.

Pierce opened discussion on the proposed resolution for the request by Zierke Manufacturing of Winnebago, MN for tax abatement for property located in Fairmont, MN.

Pruess presented a resolution for the Board to consider initiating the process or approval of a proposed property tax abatement of county taxes for property located in Fairmont for Zierke Built Manufacturing to bring all operations to Fairmont. Pruess stated that Zierke Built Manufacturing of Winnebago, MN desires to move all operations of their manufacturing business to Fairmont in the former US Foods warehouse in Fairmont, MN. Per the officials at Zierke Built Manufacturing they proposed to bring 30-40 jobs and in add 30 jobs in the next few years. It is proposed that in order to meet the needs of the manufacturer, the former US Foods building is in need of \$500,000-\$700,000 of renovations. The proposed amount of total tax abatement for the county is estimated at \$110,000 over a 10 year period, approximately up to \$11,000 per year in tax abatement from the County. The City of Fairmont will also be considering full tax abatement of property taxes for the 10 year period as well. The City of Fairmont and the County would each enter in separate development agreements. The fees associated with the proposed tax abatement (i.e. legal fees) will be paid by the City of Fairmont

Higgins informed the board that the county has a Business Subsidy Policy that addresses such subsidy requests, further stating that the county had approved tax abatement for the Trimont Town Centre a few years ago.

Under applicable law, it is necessary for the Board of Commissioners of Martin, Minnesota (the "County Board"), to hold a public hearing on the proposed property tax abatements, and the Authority hereby requests the County Board to hold the public hearing, following notice thereof having been published not less than 10 and not more than 30 days prior thereto, and to consider thereafter the proposed property tax abatements for approval at a meeting of the County Board on August 16, 2016.
